The undersigned (hereinafter "Applicant") as an authorized representative and on behalf of the above named business hereby agrees to the following terms and conditions of membership in Consolidated Electric Cooperative (hereinafter "CEC"):

1. Applicant will pay the designated membership fee if not presently a member of CEC. If Applicant is presently a member of CEC, this shall be an electric service contract only. If required, Applicant will also pay to CEC the necessary construction charges or other deposits as required by CEC policies prior to acceptance as member. Membership fee and deposits shall be refunded or applied against any amount owed CEC by the Applicant upon termination of service in accordance with board policies and bylaws.
2. Acceptance of this Applicant by CEC shall constitute a Contract for electric service between Applicant and CEC at the service location (or described premises) and shall continue in full force and effect from the date

electric service is made available to Applicant until terminated in accordance with the CEC bylaws, rules, regulations or policies.

3. Applicant will purchase from the CEC all electric energy used on the premises described herein and will pay monthly thereafter at rates to be determined from time to time in accordance with the by-laws and policies of the CEC.
4. Applicant will comply with and be bound by the provisions of the Articles of Incorporation, By-laws of the CEC, and such policies, rules and regulations as may from time to time be adopted by CEC.
5. Applicant hereby agrees that an annual amount between \$2.50 and \$3.50 of electric use or service each year is for a subscription to Rural Missouri.
6. Applicant assumes no personal liability or responsibility for any debts or liabilities of the CEC by reason of this application.
7. Applicant hereby grants unto CEC, its successors or assigns the right to enter upon the land of the Applicant located as described in this application, and to place, construct, operate, repair, maintain and relocate and replace thereon an electric distribution line and within 25 feet of the centerline of such electric line, to cut and trim vegetation, shrubbery and trees in addition to applying herbicides to the extent necessary to keep them clear of said electric line and to cut from time to time all dead or dangerous trees which may jeopardize the electric distribution line.
8. Any default by Applicant in the payment of electric bills, billed services and/or material purchases shall give the CEC the right to disconnect and/or remove the service and cancel the membership. Further, Applicant agrees to be personally responsible and liable for any and all costs associated with recovery of an outstanding balance or debt owed the CEC, including but not limited to, collection agency fees, or court costs, and reasonable attorney's fees and expenses incurred by the CEC in pursuit of a civil suit against Applicant in the appropriate federal or state court.
9. Applicant hereby affirms they are at least eighteen years of age and that all of the information in this Application and Contract and any other required documentation filed in conjunction herewith is true and correct in all matters, and in the event that any false or incorrect information is included herein, Applicant waives his/her/their right to service, and CEC can discontinue service to the Applicant without notice upon discovering such misstated or false information.

PRIOR TO THIS APPLICATION BEING ACCEPTED: A legible copy of the Articles of Incorporation filed with the Missouri Secretary of State; or if a foreign corporation, a Certificate of Authority to do business in the State of Missouri **and** a Certificate of Good Standing issued by the Missouri Secretary of State must be provided and attached hereto.
